Outdoor Buddies was made aware of the opportunity to participate as a plaintiff in a law suit related to recently passed Colorado gun control laws. After careful review and discussion, the Board determined that Outdoor Buddies will be a plaintiff in the case. A Position

Statement related to the case is included in this newsletter.

Following is information used by the Board in determining Outdoor Buddies' position.

The Second Amendment (Amendment II) to the United States Constitution is the part of the United States Bill of Rights that protects the right to keep and bear arms. It was adopted on December 15, 1791, along with the rest of the Bill of Rights. Amendment II - A well-regulated militia, being necessary to the security of a free state, the right of the people to keep and bear arms, shall not be infringed.

Perhaps no provision of the Bill of Rights is more important than the Second Amendment right of the people to keep and bear arms. The Second Amendment is the guarantee that the U.S. Constitution and all the other personal liberties of the Bill of Rights are not merely words on a scrap of parchment. The Second Amendment was created as an insurance policy, covering both personal freedom and personal protection. Freedom is as important today as it was 200 years ago, so the Second Amendment is not out of date

The advantage of being armed is an advantage Americans possess over the people of almost every other nation. This right is not merely for the defense of American borders. Rather, an armed public is advantageous in protecting political liberty.

The original intent of the Second Amendment was to provide the means necessary for the citizenry to defend itself from tyrannical government.

There is no doubt that America has a problem with mass murders, but guns and high capacity magazines are not the cause. The cause is severe mental illness; the psychotic.

But, the real cause is not being adequately addressed by gun control advocates. They should be looking at elements that provoke and enable violent fantasies supported by the entertainment industry.

The lack of focus on the real cause by gun control advocates demonstrates that there is another agenda at work and stopping mass murders is not their primary objective. Their real objective is eventual total gun control using an incremental approach to get there.

Of course, we all feel profound sorrow and sympathy for mass shooting victims and their families. However, that does not justify the erosion of the Bill of Rights. To do so would be a dishonor to the hundreds of thousands of our Nation's military men and women who paid the supreme sacrifice to defend those rights.

Over 300 people attended the Outdoor Buddies Community Appreciation Day Honoring Wounded Warriors and Other Military Personnel and Veterans on May 18th, Armed Forces Day, at A Painted View Ranch near Westcliffe. Attendees included Soldiers from the Warrior Transition Unit at Fort Carson.

Special thanks to Bill Canda for the great job he did as public address announcer for the event. He kept everyone informed and headed in the right direction.

There was an impressive flag ceremony with a mounted color guard from Fort Carson and local American Legion Post 170 color guard.

Don Paul and Jan Michel did a great acappella rendition of the national anthem and Reverend Andrew Zeller recited a stirring prayer for the occasion.

Other activities included a rock climbing wall, the Blooming Bush Women (music and Samurai Sword Dance), pack mule demonstrations by a local US Forest Service representative, a kid's fishing game, archery trailer, and laser shot video game staffed by local Colorado Parks & Wildlife representatives, alpacas from Paca Peace Ranch, an educational program with wolves conducted by Kent Weber, Executive Director of Mission Wolf Sanctuary, a tug-of-war game staffed by representatives of Colorado National Guard, stick horse barrel racing, and more.

Special attractions for kids included a bounce house, ducky races, face painting, animal balloons, and cotton candy.

Approximately 300 free meals were served including a pig roast, hot dogs, sloppy joes, coleslaw, potato chips, cookies, iced tea, lemonade, and water. Alcoholic beverages were prohibited.

The mounted color guard from Fort Carson showed off the riding skills with a rousing equestrian demonstration immediately after lunch.

Special guests included LTC Christopher Heberer representing Fort Carson. LTC Heberer filled in for Colonel David Grosso, the Fort Carson Garrison Commander, who was scheduled to attend, but was diverted to other duties. We extend our appreciation to LTC Heberer for his participation.

FOCUS ON FOREVER CONFERENCE ACCEPTING REGISTRATIONS; CPW OFFERS CONFERENCE SCHOLARSHIPS

DENVER - Colorado Parks and Wildlife and Pheasants Forever are co-sponsoring a June 7 through June 9 conference in Estes Park that will teach best practices for providing outdoor skills education. Participants will receive in-depth training in how to teach skills like archery, cast-iron cooking, shooting, canoeing, kayaking and much, much more. Sessions will also focus on teaching methods that can be used to make sure students are engaged, challenged and retaining outdoor skills for lifelong enjoyment.

The "Focus on Forever" Conference is designed to help current outdoor skills instructors improve and help organizations train new instructors all with the main goal of getting more people outdoors in Colorado.

"Colorado is an amazing state with so many outdoor opportunities," explained Allison Kincaid, Colorado Parks and Wildlife Partnership Coordinator. "People are hungry to learn new skills and get outside but individual organizations may not have the ability to offer all of this training in one place for their staff, volunteers and board members."

The Conference cost is \$325 per person but Colorado Parks and Wildlife has a limited amount of scholarship funding set aside to provide a 50-percent match for organizations that can't afford the entire fee. "Beyond building skills, we're excited to bring partner organizations together to network," added Kincaid. "Participants will learn about programs being offered by other organizations and, we hope, get a chance to find new ways to team up for greater success."

Outdoor Buddies Position Statement

May 22, 2013

Colorado recently passed the following new gun control laws:

House Bill 13-1224 prohibits the sale, transfer, or possession of large-capacity ammunition magazines (more than 15 rounds), with certain exceptions. And it requires identification markings on all large-capacity magazines manufactured in Colorado after July 1, 2013, which is when the law takes effect.

House Bill 13-1229 requires (1) universal background checks pursuant to the transfer of firearms, including private transfers, with several exceptions; (2) new mental health reporting; and (3) a judicial appeals process for individuals restricted from acquiring or possessing firearms. This law took effect upon passage, although the background check requirement does not begin until July 1, 2013.

The Outdoor Buddies Board of Directors is opposed to these statutes and any other such legislation for two reasons:

1. The Second Amendment to the United States Constitution says...“the right to keep and bear arms shall not be infringed.” This language is crystal clear. Both of these new Colorado statues clearly violate the Second Amendment and, therefore, are unconstitutional. The Second Amendment is perhaps the most important of all the original ten Amendments (Bill of Rights) in that it provides the means for citizens to keep themselves armed as protection against foreign threats and also against any kind of tyrannical government that may arise within our Nation. Those who are pushing to infringe upon our Second Amendment rights are challenging all of our rights and freedoms in the process and this over-reach by government is a clear form of tyranny.
2. Those pushing the outlawing of certain kinds of weapons and magazines are using the mass shootings as their justification to infringe on the Second Amendment. But, the cause of mass shootings is not the weapon or the magazine capacity. The cause and real problem is the mentally unstable shooter, but that is not being adequately addressed. If the politicians pushing “gun control” really wanted to solve the mass murder problem, they would look at how our society handles severely mentally ill people and at the entertainment industry that provides violent games and movies that feed the violent fantasies of some people. Since they are not adequately addressing the real problem, there must be a different agenda at work in this effort to restrict our constitutional right to keep and bear arms.

HB 13-1224 especially impacts those with disabilities because it makes it difficult to quickly change magazines under the stress of a home invasion. Wheelchair bound persons, and others with limited mobility, are severely restricted in their ability to get in the best position to repel a home invasion. Thus, they are more dependent on immediate firearms defense than are able-bodied people who might be able to flee the house or buy time by running to another room. Eliminating the ability to use magazines with a capacity larger than 15 rounds has a corresponding adverse impact on their ability to exercise their constitutional right to defend themselves, their homes, and their families.

HB 13-1229 restricts temporary transfer of firearms between persons with disabilities and others who are helping them in their pursuit of activities involving firearms. This restriction will severely hamper Outdoor Buddies volunteers and disabled members when participating in hunting and shooting sports activities.

Conclusion:

It is the Outdoor Buddies Board of Directors’ position that HB 13-1224 and HB 13-1229 will not enhance public safety, but will restrict law-abiding citizens from defending themselves, their families, and their homes. In addition; the laws are not only unconstitutional, but also confusing and unenforceable.

Murphy Creek is a challenging and fun 18 hole regulation course for all ability levels. One of the best practice facilities in Colorado, great putting green, tough chipping and sand practice green, two short game practice greens up to 75yards distance, and a full driving range. From the longest tees it features 7,456 yards of golf for a par of 72. The course was designed by Kenneth Kavanaugh, ASGCA and opened in 2000. The course rating is 74.6 with a slope rating of 13.1.
